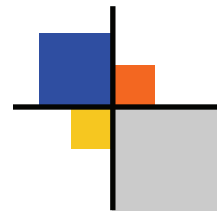

### WORMY THOUGHTS TO FISH BY: (FROM CHURCH BULLETINS)

The sermon this morning: "Jesus Walks on Water". The sermon this evening "Searching for Jesus"

### BE AWARE

Don't be a "sediment jetter"! Wha's zat? Well, it's really a kind of dredging! Many folks have complained about the deep hole just off the concrete spill way at the boat launch site. That deep hole is made by "sediment jetter's". When the day's done, the fish caught and the boat returns to the launch site, they back the trailer into the water.

The next step is nosing the boat onto the back end of the trailer and then giving the motor full steam forward which causes the bow of the boat to rise up on the trailer and the stern of the boat to sink deeper into the water. The prop wash blows the lake bottom into the lake and forms a sandbar 30 or forty feet out. In the case of the Moen Lake launch site, the lake bottom there is now down to the gravel and even that is being blown out into the lake.

Well, now, lit's not just the launch site where this is occurring. Boats taking off from shallow shoreline waters pulling a skier or just blasting out for a ride are stirring up lake bottom.

Why should we be concerned about this practice? According to Jim Grafelman\*, from the DNR, 90% of the lakes' productivity takes place near the shoreline. Blowing away the lake bottom's surface sediment removes the microscopic animal and plant life that lives there. This in turn removes the foundation of the food chain. Plants and other organisms die and our bottom feeding friends lose their source of nourishment. The result is a sterile lake bottom plus, the re-suspended sediment gets into the gills of fish causing illness and/or smothering smaller fish. Once the lake bottom is disturbed, you can never get it back.

The lesson here is to motor away from the shoreline slowly until you have reached a depth where the propeller can't stir up the bottom. For folks pulling skiers, stay at least 200 feet from shore (that's the law). Also, remember that the state has a 100-foot no-wake zone near shore (200 feet for personal water craft). Lastly, if you are considering doing sediment jetting on purpose to deepen the your shoreline, don't—it's against the law. Penalties range from \$500 plus court costs to \$10,000 per each day of violation.

The Three Lakes Waterfront Association spent \$12,100 on 414 hours of officer patrol, with 157 contacts and 25 citations written. Eagle River has 11 Associations on their side of the chain and they spent \$80,000 in 2007 to clean up AIS!
