Pride, Strides, Great Ride

Take **pride** in your Association. To start, I want to show you the great **strides** that have taken place in the past decade because of the support and dedication of you, our members! Help us keep moving forward – volunteer!

First, let me point out that this organization exists because of the personal and financial support that you all have provided. No organization can endure without it. In 2002 we had 47 members, 30 of which turned out, under the guidance of Vicky Houston and Linda Wilkins, to began the battle of preventing Aquatic Invasive Species (AIS) from gaining a foothold in our Chain of Lakes. To date, we have identified only the Chinese Mystery Snail and a rare, but native, "Farwell's water milfoil", discovered in Fifth lake by Don Mevis. These Accomplishment are due to the diligence of our volunteers who staff the boat launch site preventing boats from bringing in any AIS and YOU, the property owners, who participate in the Adopt-A-Shoreline program, looking for any unusual water or shoreline occurrences on your, or, contiguous property, and reporting it to our AIS co-ordinator, Kathy Winkler. ANY time you spend in these endeavors helps us in our ability to obtain State financial assistance and protect our lakes. This, in turn, Keeps our dues structure low. You have to admit that \$20.00 annually is a miniscule sum to

monitor our Lake water quality, prevent AIS invasion, and support our property values. Most important, is our enjoyment of the beauty surrounding us every day.

MEMBERSHIP

This year we have a paid membership of 140 (out of 287 property owners). Out of which 82 members turned out to staff the launch site this summer. This included 11 new members trained this year. Many of them "weekenders" or "weekly" visitors. This averaged out to be 413 two hour shifts. 328 boats were inspected. Still, it is not enough to completely staff the launch site and prevent AIS from getting in. If you haven't been trained or haven't had the chance to participate, please consider giving a couple hours of your time next summer to this critical task. The more folks we have available, the fewer times we would have to call on you to help.

ADOPT-A-SHORELINE PROGRAM

We need help, and I mean we need help now. Consider the fact that probably daily you and I go down to our shoreline to take in the stunning view and more than likely look over our near shore and shoreline. Keeping track of that short respite and report the time and dates to Kathy Winkler on simple forms provided would help us immensely in our Grant applications. When Kathy calls, ask if you can sign up. It's a simple way to become involved as a "committee of the whole".
