### NEW NEWSLETTER LOGO

Thanks to Bob and Nancy Rosera for the design of the logo for the Newsletter's new name "MoenBeams" reflects (no pun intended) the historic name of the chain as well as the beauty of the geography and the interest in one of the north woods grand sports – fishing. We hope you like it.

### DAM IT

At the annual meeting questions arose about the lake water levels. The Moen chain is the smallest of the state's seven water reservoirs in Oneida, Lincoln, Marathon, Forest and Vilas counties. The other six are the Rainbow, Willow, Rice, Spirit and the Eau Pleine. The dam at the outlet of North Pelican fifth lake controls our chains water levels. In all, there are 21 water storage reservoirs including those in upper Michigan providing 61,265 acres of surface water. The agency responsible for maintaining the dam and controlling the amount of water flowing through the gates is the Wisconsin Valley Improvement Co. (WVIC) based in Wausau. The WVIC was originally charged with flood control after the logging period dwindled post 1900.

The Company acquired 16 former logging dams located at the outlets of natural lakes that are tributaries to the Wisconsin River in 1907–8. From 1911–1937 five new reservoirs were built. The initial justification for creating these dams was flood control and the need to create more manageable constant water levels. Besides that, the rivers downstream are dependent on their water levels to maintain flow for hydroelectric performance and provide for aquatic river life, both plant and animal.

This past summer we experienced one of the highest rain volumes, in a short period, in decades. This resulted in high water levels throughout the system. I think it's far better than the drought that we have experienced over the past years despite the problems that the high levels may have created, don't you?

### **CLEAN BOATS/CLEAN WATER COMMITTEE (CB/CWC)**

Basically, the Chair works with our paid CB/CW coordinator, Kathy Winkler to write & monitor our annual lake Monitoring grant and to work with Kathy in our annual CB/CW efforts. A DNR representative and trained members of your association will be present to identify any aquatic specimen, be it animal, vegetable or mineral, that you have pulled from your shoreline or any other place on the chain. Place them in plastic bags with water to keep them fresh and..... come on in!

We now have about half of the property owners but more would be helpful in fulfilling our mission. We are here for them.

## ARE WE AWARE? RESPONSIBLE?

As custodians of our lakes it behoove us to use caution and diligence in what we place in them and how we use them. Besides our bodies, what are we placing in the lake? Consider the effects of the July 4th nitrates or other substances such as the paper wadding and other detritus that occurs with each explosion over water. How about the sparklers that end up in the lake? Do you go in for a swim with bare feet? Do the stems rust? Are you bathing in the lake with soaps and emollients that are free of pollutants? Is your Outboard motor leaking gasoline? Oil? If you have a lawn to the water's edge is the fertilizer phosphorus free? What chemicals in the fertilizer that you are using pollute? Does your property's rain runoff reach the lake? When water skiing or running fast with a jet ski, are you aware of the effect of the water turbulence on the lake bottom, especially in shallow areas? Are we being good neighbors? Is our evening lighting aimed correctly so as not to encroach on the adjoining properties (look across the lake, you shouldn't see a light fixture at night, only the light glow). Each property owner is just one part of a community owning, living, loving and enjoying our little part of heaven. I'm not trying to "nag" or "point fingers". All I want us to do is be good neighbors, aware of others. Thanks for reading the above.
