This scenario is not only unacceptable, it is also unsustainable.

So, I am asking you all to make an early new year's resolution. Plan now to volunteer several times next season as a CBCW watercraft monitor. Nancy Sattler, our newest MLCA board member, has offered to be our CBCW Volunteer Coordinator starting next season. Nancy worked this past season as an Oneia County CBCW trainer and I am happy to share with you that Nancy is very committed to the goals of the CBCW program. I can also alert you to the fact that Nancy is very tenacious, so you will be called on to do your part to protect our beautiful lake chain. We all should strive to be the best stewards of nature's gifts as we can be and volunteering as a CBCW monitor is a big step in the right direction.

AVOIDED**



In the early evening hours of Oct 5, 2013, a cloudy windy day, residents of 2nd Lake heard cries for HELP. Neighbors rushed to their shores and saw a young adult in the water in the middle of the lake clinging to a swamped kayak & screaming for help. They rushed into action. Some people hurried to get a boat uncovered & untied, but their engine would not start. Another started out in a canoe, but the high winds & waves prevented assistance from that method. Fortunately, a couple fishermen came through from Lake 2 1/2 at that time and were able to successfully rescue the young kayaker, who had ventured out WITHOUT A LIFE VEST and subsequently was so very close to drowning. A HUGE THANK YOU to those who saved this young life, a HUGE HUG to the one who was lucky enough to live to learn, and a HUGE REMINDER to us all to take extra care in inclement (or clement, for that matter) weather and to always wear, or have readily available a LIFE VEST. This can happen to any of us, or any of those we love, at any time.

MLCA ANNUAL MEETING

JULY 6, 2013

(Seventy one in attendance)

President Dan Kuzlik opened the meeting asking for the past annual meeting minutes & treasurer's report. Each was approved. The Association is financially stable (but not wealthy).

Nancy Sattler spoke on AIS and the CB/CW program emphasizing the importance of volunteer launch site monitoring.

DNR, Tim Plude reported that all lake and shoreland specimens brought for identification were native. No AIS identified.

Dan Carlson reported on his installation of the kiosk at the launch site. All monitoring materials are also kept in the kiosk. Also, there are two folding chairs inside for volunteer comfort. Carlson also spoke on the status of the DNR grant. The remaining moneys owed will be sent during the off season. He covered the status of the new and old markers. As many new "floaters" as possible will be installed next year.

Gary Berweger reported on the 2013 Fall fish survey. It was carried out on Monday night, September 16th on N.P. 4 & 5. Gary Berweger and Nancy Sattler attended. The results were similar to the survey of two years ago. No age-1 year old walleye were found. Some 12" size (2-3 year olds) and 20 larger walleye and were identified. A question was raised as to why the DNR does not stock Lakes 2 & 3. DNR Jon Kubisiak says that he is limited by State Administration Code regarding public access to lake waters. Fish stocking depends on the number of boat landing minimums needed based on lake acreage. For example, Moen Lake needs a minimum of 15 car-trailer parking spots adjacent to the landing. Lake 2 & 3 would require 5. N.P. 4 & 5 each require 8. Each landing site would need monitors. These access sites include private, public and pay-as-you-go sites. The last stocking on the chain was in 1998.

Sue Ohman reported that the membership is increasing. Speak to your non-member neighbors

Walt Gager requested more input from members and non-members alike for the Newsletter. He asked about having an advertising section. Members could advertise free Non members and commercial property would pay a small fee. Your thoughts?

Sally Latimer and Walt Gager reported that the picnic in August at Birchwood was a lot of fun.

Tom Cutler reported on the developing "project committee", which is the result of the Long Term Planning committee.

The new Lake Committee is being formed. This committee is meant to have a representative on the lake for all property owners. The representative reports directly to the board. A kind of Ombudsmen, if you will.

An Ad Hoc Bylaws committee must be formed to bring the rules up to date.

2014 ANNUAL MEETING

The speaker at next summer's meeting at Pine Valley Lodge will be **Bryan Pearce**, the Executive Director of the **Northwoods Land Trust**. This will be a great opportunity to get information about private land conservation easements to preserve property for future generations and at the same time continue ownership and gain tax advantages.



The Trust's mission: "...Promotes conservation by private landowners of natural shorelands, woodlands, wetlands and other natural resources.....in Vilas, Oneida, Forest, Florence, Iron and Price Counties and the surrounding region"

In the eleven years of the Trust's existence, over 9,000 acres of woodlands, wetlands and wildlife habitat, including over 40 miles of lake and river shorelands have been protected. The conservation easements and land granted to the Trust have been valued at well over 15 million dollars. Place July 5th on your calendar now.

FISH SURVEY. John Kubisiak, Fisheries Biologist, WIDNR, electrofished 4th & 5th Lakes Sept 16th for muskie & walleye. Nancy Sattler rode along. Unlike the last 2 yrs, they caught NO age-0 or age-1 size walleye. 20 larger walleyes were seen though, including a cluster of approximately 12 inches, putting them at 2 or 3 years. We will let you know the full results when we receive the report.. The photo at left shows the electrofishing in progress. John Halverson is on the right, Nancy Sattler (who had a great time, but reported sore shoulders from hauling all those muskies in for measurement!) is on the left.



FISH STOCKING! Sept 26th, the DNR stocked 10 7-9 inch walleye fingerlings per acre on 4th & 5th Lakes. The eggs were from Lake Tomahawk & the fingerlings were raised at the Woodruff Hatchery. DNR staffers Steve Marschner & Tom Lorenzen were assisted by MLCA members Gary Berweger, Don & Sue Broadbridge, Kris Krause, Bill Huber, Nancy & Tony Sattler, Dave Hansen, and Bill & Laura Disbrow. Because the Woodruff Hatchery did not have enough fish to stock Moen as well, those fish will come from the Spooner Hatchery, the date for which is pending. The Spooner Hatchery eggs are from the Woodruff Hatchery.


5 yr old Eli Berndt caught his 1st ever fish, his very 1st time fishing, within his very 1st 10 minutes of practice casting!




Tim Barr, from VA, while visiting his brother Greg, caught this 36 1/2" muskie on 4th. 1st time muskie fishing!


Steve Berndt caught this beautiful crappe on opening day.
