Meet Our New Oneida County AIS Staff!

On May 17th, Blake Borchardt (top) and Tim Plude (bottom) began their duties with Oneida County as AIS Project Assistants for the summer. On day two, they were off and running; literally getting their feet wet doing watercraft inspections following the Clean Boats, Clean Waters (CBCW) program model. Performing watercraft inspections at boat landings will consume the majority of their time, but they will also assist with: workshops and presentations, installing signs and boat bumpers (see bumper picture below), producing educational materials, etc.

Blake and Tim are both at senior-levels at the University of Wisconsin -River Falls, majoring in Conservation with Biology minors. Blake is also pursuing a minor in Criminal Justice. His hobbies include fishing, hunting (he's hoping to fill his bear tag this year), and camping. Tim enjoys fishing (he's an avid fly fisherman), camping, hiking, and spending time with family and friends. Educational Outreach Regarding AIS in Oneida County

It's hard to believe that it's almost July already! The last couple of months have flown by, and I'm starting to loose track of the days. Needless to say, things have been busy, but it's also been a lot of fun. During these last few months, we've been meeting and presenting to lake associations, school groups, and town boards, installing boat bumpers (picture below) on piers at landings throughout Oneida County, conducting CBCW and Citizen Lake Monitoring Network (CLMN) workshops, performing **CBCW** watercraft inspections and education efforts, participating at area events, and more! Before school was let out this Spring, I was able to

conduct educational programs with Rhinelander, Three Lakes, and Tomahawk students on issues pertaining to AIS and how they can affect our waters and personal enjoyments. The students really seemed to enjoy seeing the species up close, learning which ones are concerns in our immediate area, and knowing that our inland waters are free (presently) from species like the "toothy" sea lamprey!

Along with the help of local Wisconsin Department of Natural Resources (WDNR) staff, Blake, Tim, and myself have hosted three CBCW workshops and one CLMN workshop. We've had 37 workshop attendants who are now trained to implement the CBCW program and/or monitor the health of our water resources using CLMN protocols. The overwhelming majority of these workshop participants are volunteers; committed to learning more about how they can help protect our beautiful lakes and rivers. Hats off to them for their stewardship!

Reports on Recent Wisconsin Lakes Conferences

Between March 30th and April 1st, I attended the 2010 Wisconsin Lakes Convention (WLC) in Green Bay. Being that I had only been on the job for a little more than a month, the WLC was a great opportunity for me to meet a wide array of people working to protect our waters here in Wisconsin. Individuals from lake and river organizations, private consulting agencies, natural resources agencies, and others simply interested in protecting water resources were all present. The theme of the convention was, "Restoring Wisconsin Shorelands and Shallows."

The three day event was filled with dozens of educational sessions, numerous workshops, guest speakers, and an awards ceremony. The WLC was very informative, and I look forward to attending again next year.

On June 19th, the Wisconsin Association of Lakes (WAL) hosted "A Northwoods Lakes Workshop" at Nicolet College (Lake Julia Campus) in Rhinelander. A number of lake groups, including the Oneida County Lakes and Rivers Association, along with the WDNR, sponsored the event.

Presentations on current research, shoreland restoration techniques and projects, and updates on current water resources policy initiatives, were given (just to name a few). There was also designated time for individual county meetings and networking. The workshop was well attended, and it was a great opportunity to discuss issues specific to the Northwoods. It was also interesting to see what was going on in neighboring counties. Look for events like these in the future, and get involved!
